1. Welcome and background to the meeting

S Babu welcomed all to the online General Assembly and the 41st Annual Meeting. It was good to see such good participation at this virtual meeting which was a result of how COVID-19 has forced us to work in this 'new normal'. 16.1 million people worldwide have been affected by the pandemic with the highest numbers in America, Latin America, Europe and Asia. COVID-19 has affected us in a number of ways and has had a huge economic impact.

We were able to hold our Annual Meeting in Glasgow in January this year but then one month later the effects of the pandemic started to show in Asia, Europe and then USA. This did affect the planned WCNDT in Korea this year and a number of brainstorming meetings between the ICNDT and the KSNT organising committee were held to discuss how best to handle this.

On the 4th March 2020 it was decided to delay the WCNDT and on the 10th April there was an official announcement that the event was to be postponed. It was agreed that the existing officers would continue in their roles until the postponed WCNDT in 2021. Several members requested to have an online GA, hence this meeting today.

D Gilbert ran through the agenda and the meeting etiquette. It was pleasing to welcome so many people to the meeting today, all of whom were thanked for their participation.

All participants introduced themselves and a quorum was established.

Apologies were received from H Jansen due to ill health and everyone wished him well.

2. Memoriam

We had not been informed of any deaths since the last meeting.

3. Minutes of the 40th GA – June 2018

The minutes of the last GA has been circulated prior to the meeting. On a proposal by P Wadyalkar, seconded by L Dick, the minutes were approved as a true record.

4. Procedure for Voting and Quorum

M Farley advised that there was one vote for each regional assembly, one vote for each region and one vote for each member society. However, it was not expected that there would be many items to vote on at this meeting and normally voting is only carried out if information has been circulated in advance.

5. Annual Report 2019 (Balance and Budget)

The Annual Report was presented. S Babu advised that the report had been approved at the Annual Meeting in January. The draft budget for 2020 had also been approved and G Aufricht was invited to give some detail on the 2020 finances.

The 2020 Budget, Rev 1 and 2 were presented. G Aufricht pointed out that the income from the WCNDT 2020 has been postponed until next year so revision 2 of the budget shows zero income for WCNDT. Under the new structure, membership fees for 2020 were €22,792 which is more than the amount shown in Rev 1 of the budget. There was no change to the other items in the budget. The membership fees had been broken down into the different regions but not all fees for 2019 have been paid.

G Aufricht asked for acceptance of Rev 2 of the budget. The balance showed no meeting costs, income of \in 128,955 and expenditure of \in 9,282.

G Aufricht advised that a slight change to the accounting framework for 2021 will be considered. For example there will be a new cost of personal expenses for the new WG1 Secretary. A Mullin pointed out that C Bird is Secretary of ICEC and not WG1 so this expense is not related to WG1. A Mullin and G Aufricht to discuss outside of the meeting.

We have taken out the €30,000 donation from WCNDT and have taken out the membership fees through the new structure for the four regions.

S Babu advised that a balance of €152k was approved in January but our rolling forecast as of today is expected to be €120k due to the shortfall from WCNDT. Overall our finances are healthy and G Aufricht was thanked for keeping our finances on track.

6. Officers and Secretariat (2020-2021 update)

S Babu thanked BINDT for their support over the last four years in providing the secretariat to enable ICNDT to function efficiently. He also thanked all of the officers for their contributions over the period 2016-2020, as well as all members for their continued support.

The current officers will continue in role until WCNDT 2021.

In accordance with OP1, six months before the WCNDT next year, a request for nominations will be sent by email. Nominations will then be reviewed by the IEC,

7. ICNDT Awards and Honorary Memberships

ICNDT awards and Honorary Memberships will continue until the 2021 WCNDT.

S Babu thanked all Federations for their support and advised that we have 64 member societies and 4 regional members.

On behalf of all members, M Farley proposed a vote of thanks to S Babu who has worked very hard, sometimes under difficult circumstances, over the last four years and who has agreed to remain in post for at least one further year.

8. Membership

J Conte reported that there are 64 organisations within ICNDT; 55% from Europe, 27% from Asia Pacific, 12% from PAN America and 6% from the Africa region. A copy of J Conte's report is attached.

S Babu advised that there have been a lot of changes to the Operating Procedures and asked M Farley to brief the meeting on the changes. M Farley reported that the IEC has been reviewing and revising OP11 – Membership. We wanted to clarify that any society that is accepted into a region is automatically accepted into ICNDT but the starting point for the application would be through the region. The new text has now been agreed within the IEC and, after some small editorial changes, will be sent to members for approval by postal ballot.

G Aufricht asked if OP1 would also include clarification of members who do not pay their fees and what would happen to their membership. M Farley advised that the procedure does not currently say anything about non-payment of fees and he suggested that this be referred to the IEC for review.

The general view is that fees for membership for small societies have been reduced dramatically and we would expect these fees to be paid. If members do not pay, the immediate sanction would be no vote at the next GA and then soon after, removal of that society from membership. We will check to see where this is actually stated in our documentation. G Aufricht agreed that societies should commit to pay the €100 low membership fee or leave ICNDT. Under normal circumstances we would collect some membership fees in cash at WCNDT but unfortunately we will not have the opportunity this year.

S Babu thanked members from Europe, Africa, Asia and Pan America who have been supporting us financially. There will be a significant change for the growing states in Category D or E membership which will be really helpful. This will be acknowledged at the next General Assembly. We know that this is a difficult period but we would request all members to support ICNDT by paying their fees. If anyone is experiencing difficulties they are asked to let us know.

9. Regional Reports

9.1 <u>AFNDT</u>

The AFNDT report is attached.

9.2 APFNDT

N Ooka presented the attached report.

P Wadyalkar pointed out that the APFNDT wants to grow and accommodate more societies. He did not agree with the policy that if members do not pay their fees they should be asked to leave. We could cancel their voting rights but we should not cancel their membership if they cannot pay. P Wadyalkar requested that the IEC gives consideration to developing societies.

S Babu commented that it would be good if the regions that are close to member countries have good communications with them. He believed that the regions should have a role in communicating with the countries that are not paying.

9.3 <u>EFNDT</u>

F Gomez presented the attached report.

The EFNDT has 31 Full Members and 9 Associate Members.

M Farley asked F Gomez to explain what the RIMA project is. F Gomez advised that RIMA is a European Union's Horizon 2020 funded project on Robotics for Inspection and Maintenance. The project was launched last year and a lot of companies and countries are participating in it. Peter Trampus is the EFNDT contact for the project.

With regard to NDE 4.0, M Farley advised that there is an ICNDT specialist international group led by Dr J Vrana. An NDE 4.0 Ambassador has been appointed and an international conference, co-sponsored by ICNDT has been organised. M Farley was concerned that there were too many groups looking at NDE 4.0 and he asked all to support the ICNDT specialist group.

F Gomez believed that it was important to improve communication between ICNDT and the Federations or there could be problems with competition between the groups. F Gomez suggested some combined meetings with EFNDT and ICNDT perhaps every three months. M Farley commented that this is an important topic to work on internationally across the globe. There was going to be a large workshop on NDE 4.0 at the WCNDT so we will need to organise something leading up to the WCNDT next year.

D Gilbert advised that this point was taken on board at a meeting last week and things will change with improved communication being implemented.

P Wadyalkar advised that the first meeting on NDE 4.0 was held in the USA last week and it was reported that the sub groups i.e. EFNDT and APFNDT should all be reporting through ICNDT. M Farley was pleased to hear about all of this cooperation.

T Erhard advised that a small meeting was held last week and the conclusion of that meeting was that a roadmap will be created. Once the roadmap has been completed we will discuss together and see what is going on around the world. It was also agreed that national societies and regional members of ICNDT would participate as ambassadors.

D Gilbert commented that the people who drove this in the first place wanted as much publicity and dissemination of the information as possible which is understandable, but the coordination has been lacking until now.

9.3 PANNDT

J Conte presented the attached report on the activities of the PANNDT.

10. Strategic Plan

S Babu reported that the plan is updated every two years and was last updated in 2018. The ICNDT carries out the actions in accordance with the Strategic Plan. S Babu thanked all of the working group members and chairs for diligently responding to their actions.

We are now preparing Rev 11 of the Strategic Plan for the next four years and S Babu, M Farley and D Gilbert have been working on this which will be presented at the General Assembly next year.

We have established good relationships with other organisations such as ISO, IIW, IIE etc. and these relationships are important to keep our Strategic Plan up to date.

The ICNDT specialist group for NDE 4.0 is taking the lead and we are planning to hold a webinar this year.

Moving forward, we are also seeing an increasingly mobile workforce and the national certification schemes are very well recognised internationally and more and more sister societies are working closer together.

The ICNDT MRA continues to grow with more certification bodies being recognised under Schedule 2.

In terms of Action 5 of the Strategic Plan, NDT is surviving well in terms of the economic downturn but we are also seeing serious threats due to COVID-19.

Since 2018 we are seeing more close collaboration with the regional federations and more and more regional federations are supporting the smaller societies as well as the new fledgling societies. The ICNDT has a global role to play in this.

The SWOT analysis is being reviewed and will be presented to the IEC in the coming months. The first draft of Rev 11 of the Strategic Plan will be circulated by the end of this year for deliberation and approval at the next General Assembly.

WG1 - Qualification and Certification

A Mullin presented the attached report.

A Mullin was thanked on behalf of the ICNDT for chairing WG1 and for the excellent work that he is doing.

ICEC

C Bird presented the attached report.

All but three of the 25 PCBs have responded to the request to update their date. Y Cho advised that KSNT will be ready to move to Schedule 2 by the time of the next WCNDT in June 2021.

C Bird advised that CSWIP are also in the process of becoming a Schedule 2 member.

G Aufricht commented that we should be very careful when we talk about compromises such as paper verification during COVID-19. We should at least meet the process quality of the European accreditors. If we are weak, our customers may have problems. S Babu said that the compromise is not on the quality of the renewal paperwork, it is on the timeline and a six months extension has been granted to submit all of the necessary paperwork.

WG3 - Education and Research

The report presented by T Erhard is attached.

D Gilbert presented some information on the first International Conference on NDE 4.0 (<u>https://conference.nde40.com/</u>), being organised by DGZfP and co-sponsored by ICNDT. This conference is split into a virtual conference in 2021 (with invited presentations only) and an in-person conference in 2022, planned as follows:

- Virtual Conference April 14/15/20/21 2021 with four days of invited presentations on the subject of NDE 4.0 (3 hours each day including a panel discussion, 2 time slot options to choose from to accommodate all time-zones)
- In-person Conference April 26 28 2022 in Munich, the call for abstracts is online.

WG4 – Communications

S Ooka presented the attached report.

Progress is being made with the new website at an estimated cost of around €20k. It is hoped that the website will be open for testing at the end of this year with the full website up and running by the time of WCNDT.

T Erhard asked how many ICNDT meetings would be held after the WCNDT. With regard to TC135 SC7, S Ooka will be contacting KSNT to see if we can hold the TC135 meeting before or after WCNDT and the exact date will be confirmed.

WG5 - Radiation Protection and Safety

D Gilbert gave a brief report on the ISEMIR-IR project.

WG6 – CM and Diagnostic Technology

A report from C Belinco/L Gelman is attached. Anyone interested in joining WG6 was asked to let C Belinco know.

11. WCNDT

Y Cho presented the current status of WCNDT participation. There are still more than 1,000 abstracts submitted, which is record breaking.

D Gilbert asked if anyone who had originally submitted an abstract to the conference would have to resubmit. Y Cho advised that this is not the case.

As of today, there are a total of 25 sponsors.

The official title 'WCNDT 2020' will be the brand name.

We may still face further challenges this year and next year with the COVID-19 situation and we will need to come up with an alternative contingency plan as soon as possible.

The overall numbers for next year are still looking very promising and Y Cho thanked everyone for their strong support.

S Babu suggested that it would be a good idea to create a WCNDT 2021 link to the existing WCNDT 2020 website and he asked KSNT to look into this.

It is hoped that we will have a clearer position at the end of this year as to whether there will still be travel restrictions in place next year due to COVID-19.

12. APCNDT Conference 2021

P Wadyalkar presented the plans for the Asia Pacific conference in 2021, organised by AINDT. The rescheduling of WCNDT to five and a half months before the APCNDT Conference has had a big impact in terms of the number of delegates, exhibitors etc. The APCNDT was scheduled to be held in Melbourne from the 18th October 2021 and Melbourne is in the same Asia Pacific Federation region as Korea.

We are exploring options to postpone to October 2022 but we would have to involve the chairs of all national societies in the region so that the damage that would happen to AINDT will not also happen to other societies.

P Wadyalkar felt that the WCNDT organising committee should have invited the APFNDT Chair to every meeting where discussions on deferring the WCNDT had taken place, then both countries and federations would be less effected compared to the mammoth challenge that APFNDT may have in October 2021.

APFNDT was willing to hold a joint conference with WCNDT because we were in the same region. AINDT was prepared to make some adjustments but the lack of consultation in a timely manner was not beneficial to all of the parties involved.

The AINDT as part of the APFNDT is committed in that our actions will not lead to any hardship, difficulties or challenges to any other international conference or NDT body. The AINDT will consult with all other federations and NDT bodies to ensure that our rescheduled dates do not clash or overlap with other events or force them to postpone their conferences.

As the EFNDT Conference is scheduled to be held in Lisbon from 6-10 June 2022, the AINDT would cancel the APCNDT until after this event so that there is negligible effect on the EFNDT or the Portuguese Society of NDT and we will show this same consideration to all other societies.

The worst case scenario will be that the APCNDT will go ahead as planned in October 2021 and we will do our best to invite, encourage and entice most world leaders in NDT to visit Australia in 2021. However, unless a COVID-19 vaccination is in place for all, P Wadyalker believed that it will be difficult for people to enter other countries next year.

For the AINDT to go ahead with the APCNDT next year, we will incur major losses and may even have to move the event to a cheaper venue in another city. The AINDT is a small society and we do not want to go bankrupt or end up with huge conference losses because of the decision to hold the WCNDT just a few months before our event.

P Wadyalker went on to say that, although we have been affected by the rescheduled WCNDT we will do our best to accommodate all countries and ensure that other societies do not go through the same hardship that the AINDT may go through. P Wadyalker requested that ICNDT and federation leaders should learn lessons from this and each of the four federations should prepare procedures for the future to ensure that conferences do not occur in the same region for at least two years. If something like this cannot be avoided, then the WCNDT and the local federation should have a provision that they accommodate each other and run a joint conference rather than individual conferences. There should also be a provision in our OP for a decision on conference cancellation. Under no circumstances should a society have to endure hardship due to the actions of another society.

With regard to the position of WCNDT 2020, S Babu advised that the decision is made every four years, two cycles in advance, which meant that the decision on the 2020 WCNDT was made in 2012. The decision to hold the APCNDT in Australia was decided in 2013 so there was a one year gap. The decisions on the regional conferences are made by the federations. S Babu pointed out that the ICNDT World Conference is encouraged to move around the different regions.

We do have to be careful as the conference cycles are very close other than Europe where there is a twoyearly cycle between EFNDT and ICNDT conferences.

The COVID-19 pandemic was unavoidable but it was acknowledged there should have been closer dialogue between AINDT and KINT to ensure that these discussions happened. KSNT is responsible for the profit and loss of the conference so has to take into account the views of those who have already paid money. We will however look at our OPs to see if improvements can be made. The OPs are on the ICNDT website and S Babu invited all society presidents to look at these and consider any improvements for discussion at the next GA.

Y Cho commented that he was very sorry to hear the comments from P Wadyalker and the AINDT but nobody expected this pandemic situation to happen. We had to consult with all of our returning clients

and major sponsors and they were supportive of postponing the WCNDT by a year. KSNT will put in a lot of effort to support and help the AINDT conference.

D Gilbert supported everything that S Babu had said and reiterated that it was a very difficult, unprecedented situation which the WCNDT organising committee was faced with. The committee really did endeavor to try and take everything into consideration and we believed that the correct dialogue was taking place. We were also informed that the exhibitors and sponsors would support both the WCNDT and APCNDT event. We also believed that many of the delegates would continue to support both events. All of this was taken into account and D Gilbert guaranteed that everything was done in the best interests of all concerned. We will be looking closely at our OPs with this in mind and we perhaps need to have a risk management system in place so that we are prepared for this eventuality happening again.

L Dick remarked that the APFNDT was not consulted on regarding the postponement of the WCNDT. We all have a lesson to learn and we need to write some procedures around how to deal with this in the future.

P Wadyalker apologised if his message was taken in the wrong way. The intention was not to tell KSNT that they had done something wrong.

M Farley pointed out that there must still be concern as to whether either conference can go ahead next year and we may need to think about having an alternative plan to include both WCNDT, Australia and EFNDT because it may be that none of these events are able to physically happen.

13. Reports from international societies.

Presentations were given by a number of societies as to how they are dealing with the COVID-19 situation. The following nations' societies presented:

3. Annual General Assembly

Due to a combination of non-related factors, a physical Annual General Assembly (AGM) was repeatedly rescheduled, without any of these dates being realized. Factors that diverted the efforts of holding an annual general assembly in South Africa included the following:

- a) COVID-19 pandemic
- b) Restructuring within the current secretariat

Subsequent arrangements have been initiated to hold a virtual AGM prior to the end of 2020. Items on the agenda include the following:

- a) Adoption of the new constitution and structure
- b) Establishment of the Board and election of relevant signatories
- c) Establishment and adoption of related operating procedures
- d) AFNDT Strategy and action plan
- e) Regional Conference : 8th ACNDT Conference Morocco
 The 7th ACNDT (26 to 28 November 2016) was held in Oran, Algeria, under the leadership of Dr Zergoug.

4. Impact of COVID19

The COVID19 pandemic has highlighted the deficiencies within the current AFNDT, regional NDT activities and infrastructure relating to communication and operations, increasing the criticality of an AGM. Some of the items that require attention include the following:

a) Localization of skills

Most African countries utilize foreign NDT personnel to perform testing, due to the limited local personnel compliant with international code / standard requirements or due to contractual stipulations. The restriction of international travel, as a result of the COVID 19 pandemic, has had a significant impact on statutory / maintenance inspections, because foreign personnel were no longer allowed to travel internationally. These inspections therefore had to be postponed or even cancelled, resulting in additional burden on already overstressed infrastructure. In most instances these inspections were regarded as essential services and consequently would not have been affected by the relevant lockdown conditions was it not for the need of foreign personnel.

Therefor the localization of skills is critical to ensure that national infrastructure is tested and maintained in order to facilitate ongoing delivery of essential services relating to water and sanitation; power generation & distribution and transport. Related economic sectors such as petrochemical, mining and fabrication, while not necessarily considered as essential, adds to the economic growth within a region and needs to be maintained until lockdown conditions allows for these sectors to become active again.

b) Training

Training of personnel has been performed via a direct face-2-face interface between lecturer and students at various approved training organizations. Due to travel restrictions and personal distancing requirements, this option of transferring knowledge and skills, no longer prevails and a large number of training organizations faces the very real possibility of closures.

The anticipated accommodation of a blended learning approach within ISO 9712 has provided a much needed life-line to training bodies that are in the process of adopting a technology based theoretical interaction followed by a limited face-2-face practical interaction with students. The consequent advantages relating to travel and accommodation as well as scheduling and time allocation can therefore be unlocked.

c) Qualification & Certification

Qualification and certification processes, requiring an assessment / examination have also been influenced. Various options are being investigated in this regard, with the help of other regional federations, but again, a sustainable national qualification and certification body would be the end-goal in each of the AFNDT countries in which NDT forms an integral part of engineering.

d) Statutory recognition of NDT

While statutory recognition of Inspections / Inspectors is in place for some of the regional countries, recognition of Non-Destructive Testing & Personnel remains a challenge. The NDT industry within South Africa has embarked on this process and positive outcomes are anticipated within the not too distant future.

5. Conclusion

The AFNDT faced challenges prior to the COVID19 which was just exponentially amplified as a result of the pandemic and has to be resolved prior to the end 2020.

Schedule 2 Continuity Check (Form C)

- All MRA Schedule 2 members have been contacted to complete form C and register their continuity of registration.
- To date Malaysia and China have sent me their documentation.
- The OP19 form C does not apply to OP20 registrations such as China and Brazil. This needs to be discussed.



ICNDT Conformity Assessment of Personnel Certification Bodies (OP20)

- In situations where independent accreditation of PCBs is not available or considered sufficient, ICNDT may offer a conformity assessment to support an application for registration under the MRA Schedule 2.
- There were no conformity assessment audits required during 2019 or 2020. However one audit will be required for ChSNDT in 2021. It is suggested that an auditor is appointed in December 2020.





PCBA Status

Currently 13 out of 25 PCB have responded to the request to update their data. They have been reminded and informed that the update is required by 30th June 2020. They have been reminded again and we plan to wait to the end of July for responses.

One or two of the responses have relied that the data is up to date but the number of certificates has not changed. This had been questioned but no response to the question of no change.

ISEMIR-IR

ISEMIR is the acronym for the Information System on Occupational Exposure in Medicine, Industry and Research.

ISEMIR-IR is a web-based tool for non-destructive testing companies carrying out industrial radiography (IR). ISEMIR-IR is developed as a tool for regular data collection and analysis of occupational doses for individuals in IR, and for the use of this information to improve occupational radiation protection.

It assists IR facilities in benchmarking their arrangements in radiation protection and safety, and hence in promoting of, implementation of optimisation of occupational radiation protection.





ISEMIR-IR

In 2019 in the IAEA General Conference Resolution GC(63)/RES/7, Member States requested the Secretariat to promote ISEMIR to strengthen the safety of workers who have a risk of exposure to ionizing radiation in the fields of medicine and NDT services and recommended that Member States provide data on occupational exposure to the ISEMIR programme.

For the purpose to promote and assist the development of ISEMIR-IR the ISEMIR-IR Working Group (WG) has been established.

One in-person meeting and 3 webex meetings held in 2019; one in-person and one webex meeting 2020 and another to be held 5 August.





In order to increase the number of active users in the system, as well as enhance users' experience, two new surveys are being launched: one for to regulatory bodies and one for NDT companies.

New impetus in promoting ISEMIR-IR and encouraging completion of the surveys.

WG5 basically consists of the ISEMIR WG members but others are invited.
