

# Minutes of the 33<sup>rd</sup> ICNDT GENERAL ASSEMBLY MEETING Monday, 27 October 2008 Shanghai, China

### 1. Welcome

### 3. Procedures for voting, quorum

The General Secretary reminded members of the procedure for voting. One voting delegate is permitted per member society. 33% of membership was required for quorum and only 1 proxy was permitted per member country present. A simple majority was required.

(Note: changes to Constitution/Terms of Reference require 6 months notice and positive vote of two-thirds of those present).

There were at least 32 voting delegates present hence a quorum was achieved.

There was one proxy: Czech Republic.

### 4. Report by membership WG

Tony Sonneveld (TS) confirmed that the following:

were ratified as full members of ICNDT as all the relevant criteria had been met.

TS welcomed J Conte (JC) to the chair of the Membership Committee. Finally the Chairman noted that it was TS's last meeting as Chair of the Membership Committee and thanked him for all his efforts over the years.

### 5. Election of Officers

DM announced that with regard to nominations the correct procedures had been followed, responses had been reviewed by the Executive Committee and the PGP and voting would take place according to the rules. The nominations for ICNDT officers were as follows:

### 6. World Conferences

### 6.1 Report on 17<sup>th</sup> WCNDT

Dr Rong Geng (RG) presented up-to-date statistics concerning the conference, noting that the schedule change had resulted in cancellations and fewer attendees than originally anticipated.

Registered delegates to end 25 Sept: 697 of which overseas delegates – 479, local 218 Exhibitors – 202, comprising 124 foreign; 28 local On an encouraging note there had been more than 3000 visitors to the exhibition on the first day.

He elaborated on certain mitigating factors in the reduced attendance, including the devaluation of the US\$ against the Chinese Yuan currency; the high number of complimentary registrations (c. 200); and the financial crisis currently being experienced around the world.

He stated that the Chinese Society understood the financial challenge faced by ICNDT and would try its best to make a substantial donation. The full financial report would be issued soon after the conference.

### 6.2 Report on 18thWCNDT

Manfred Johannes (MJ) referred to his presentation at the previous meeting, and also to the website:

He confirmed the dates: 21-24 April 2012.

DM congratulated MJ on the progress achieved to date.

# 6.3 Election of host for 19th WCNDT

The President of the Indian Society for NDT read out a statement on behalf of the Society. It stated that the ISNDT had had a long and close relationship with the German Society for NDT over more than 20 years. As there had been no WCNDT in Germany for more than 40 years the Indian Society had decided to withdraw its bid and support the bid of Germany instead. ISNDT thus proposed that Germany be awarded the 19<sup>th</sup> WCNDT.

The ICNDT Chairman thanked ISNDT understanding and co-operation. He felt that their decision contributed to the betterment of the organisation.

Mathias Purschke (MP) of the German Society thanked the Indian Society for giving them the opportunity to organise a WCNDT and for putting their trust in DGZfP.

The meeting approved the appointment of the German Society (DGZfP) to organise the 19<sup>th</sup> World Conference in 2016.

A general discussion followed concerning world conferences.

DM stated that he felt a measure of success is that when people leave the conference they feel they have got value for money. The World Conference was a platform to transfer knowledge, network and meet friends old and new. He believed the Chinese Society had accomplished this and he was joined by the full meeting in congratulating the Chinese Society on a successful conference.

DM presented a gift to CHSNDT on behalf of the Canadian Society. TS presented a gift to CHSNDT on behalf of the Australian Society.

#### 6.4 Awards

The awards for the best booths were presented in the following categories:

- (i) countries with <50m inhabitants Ukraine Society for NDT
- (ii) countries with >50m inhabitants but <100m German Society for NDT
- (iii) countries with >100m inhabitants Chinese Society for NDT

### 7. WG3 Research and Education

Dr Baldev Raj (BR) referred to his presentation made at the previous meeting.

# 8. Strategic Planning of ICNDT Activities

JMF outlined the approach:

SWOT analysis

Gap analysis

Strategies

Actions

Tasks for new Executive Committee

JMF said that he had conducted some research and had drafted some broad headings. He requested feedback.

### (a) WG1 Certification

A workshop had taken place that morning that had been very constructive and further suggestions had been invited.

The Malaysian representative said that much had been achieved considering the large number of differences there were from all over the world. A great deal of effort was still required, and time was against us.

Giuseppe Nardoni (GN) referred to the subject of minimum requirements and re-iterated that work needed to be done quickly. There were people already operating in the field and there was little information for them to go on. He emphasised the need for collaboration and stated that ICNDT needs to publish documents like the ICNDT Guidelines.

# (b) WG3

There was a need for an action plan based on BR's presentation.

DM raised the issue of the possibility of dividing the group into one covering education and one on research.

### (c) World Conferences

ICNDT should consider how these could be improved.

RFL stated that no procedure exists at present and if there was this could be very useful. Leslie Dick (LD) concurred. Rainer Link (RL) added that this would be the case especially if the budget was covered.

DM stated that the Canadian Society had produced a document but that this was not part of the ICNDT procedures. MJ confirmed that they had received useful data from CINDE.

GN called on the authorities to comment on how industry should be approached for support.

B Venkatraman (BV) thought that special sessions, for example the land mines one in Montreal and the art one in Rome, were useful attractions. He also believed that there was a large number of people who were only interested in the exhibition and perhaps there could be a new category of delegate who only visited the exhibition and social/cultural events – all events except the technical sessions.

RFL stated that the method of host selection should be reviewed. Putting together a bid is expensive and perhaps an initial filtering could be used to select a shortlist of only two to bid in full.

DM suggested an ad-hoc committee should be formed to consider all the suggestions.

Yeo Yanteng (YY) pointed out that any additional profit earned by the World Conference was to the benefit of NDT in general.

Rainer Link (RL) suggested that funds should be allocated to attract younger people to attend.

Yeo Yanteng (YY) suggested a nominal rate for students.

JMF mentioned that a meeting had been arranged with the exhibitors to get their feedback.

Everyone was encouraged to send in their ideas and suggestions to the secretariat, on this topic and others, for example: What would you like ICNDT to do?

All suggestions would be considered in due course.

### 9. Reports by external organisations

11.1 ISO TC 135

Hajime Hatano (HH) presented his report.

Some discussion followed. J Zirnhelt (JZ) reminded all that TC135 was established as a result of a 1967 meeting of ICNDT.

JMF reported on the relevant results of that morning's certification workshop, where the differences between the three standards ISO 9712, EN 473 and CP 106 were identified and considered. He suggested a joint meeting between ISO TC 135, 138 to discuss harmonisation of EN 473 and ISO 9712. There followed a further discussion about the ICNDT Recommended Guidelines for Qualification and Certification of NDT personnel, and in particular section 7: Recommendations. In summary a set of recommendations had been agreed upon, it was just necessary to get the English right.

The representatives of ISO TC 135 were thanked for their participation. All actions would be pursued and it was clear that everyone involved would do their utmost to deliver results.
