1. Scope

This OP sets out conditions for the use of the ICNDT logo and insignia in published material.

2. Definition

ICNDT logo No 1: The mark in Figure 1 is the official mark used on all letterheads, minutes and memoranda relating to ICNDT.

ICNDT logo No 2: The mark in Figure 2 is an alternative for use on documents where the spelling-out of ICNDT is deemed unnecessary.

ICNDT logo No 3: The mark in Figure 3 is for use in electronic media, in particular websites.

3. Form and display of logo

- The use of the ICNDT logo, other than for official ICNDT business, shall require the full approval of the ICNDT Executive Committee.
- The ICNDT logo can only be used in the forms in Figures 1,2,3.
- If used in larger or smaller size then the proportions shall remain the same.
- The font used and the colours of the logo shall remain the same.

4. Terms of use

• ICNDT Members are encouraged to use an appropriate ICNDT logo

to signify their membership of ICNDT.

- Members may use the logo in connection with ICNDT's cosponsorship of conferences and exhibitions with permission of the ICNDT Executive Committee. Permission will be granted only to international events in English or with interpretation, open to all ICNDT member societies that do not conflict with WCNDT or regional conferences. If used in conjunction with other logos, each should not be shown with more prominence than another.
- The ICNDT logo constitutes the ICNDT trademark, and should only be used in these forms. In no circumstances should the logo be interfered with in any way.
- The logo should not be used in a misleading way.
- Organisations authorised by ICNDT to use the logo will be provided with a master copy by the ICNDT Secretariat.
- A register of approved organisations shall be kept by the ICNDT Secretariat.

5. Use of the ICNDT logo by personnel certification bodies registered under the MRA Schedule 2




Figure 4. ICNDT Logo for use by personnel certification bodies registered under the ICNDT MRA Schedule 2

 Personnel certification bodies (PCBs) which are currently registered under the ICNDT multi-lateral recognition agreement are allowed to use the special version of the ICNDT logo shown in Figure 4 below. This version of the logo may be used on certificates or other documentation produced by the PCB in connection with its certification activities. The logo may be used by currently registered PCBs without requiring permission from ICNDT. However, PCBs are advised to check with their accreditation bodies that such use is acceptable.
